



Call for Session Proposals

Society of Architectural Historians 79th Annual International Conference Mexico City, Mexico, April 15 to 19, 2026

The 79th Annual Conference of the Society of Architectural Historians (SAH) will be held in Mexico City from Wednesday, April 15 to Sunday April 19, 2026. The Society invites everyone interested in the history of the built environment to submit a proposal to chair a session at the conference.

Since the principal purpose of the SAH Annual International Conference is to inform conference attendees of the general state of research in architectural history and related disciplines, session proposals covering every period in the history of architecture and all aspects of the built environment, including landscape and urban history, historic preservation and cultural heritage are welcome. The scope is global.

Sessions may be theoretical, methodological, thematic, interdisciplinary, pedagogical, revisionist or documentary in premise and have broadly conceived or more narrowly focused subjects. Sessions that embrace cross-cultural and transnational topics are particularly welcome. Session proposals that focus on Mexico City, Mexico, and Central America, in particular, are encouraged. They may address critical issues in architecture in any period or topics that intersect architecture with archeology, environmental studies, landscape design, and art history.

Each session will comprise 5 papers, with each presentation allotted a duration of 20 minutes. SAH encourages diverse presentation formats. In every case, the subject should be clearly defined in critical and historical terms. Proposals will be selected on the basis of merit and the need to create a well-balanced program.

NEW for 2026 - Call for Sessions as well as the Call for Papers will be published in both English and Spanish. Session proposals should be submitted in English.

SAH welcomes SAH Affiliate Groups, SAH partner organizations, and other groups in the field to submit a proposal to organize a session. The Society also seeks proposals for sessions that further the goals of the [SAH IDEAS Initiative](#) Inclusion, Diversity, Equity, Accountability, and Sustainability. We are thus seeking sessions that explore the intersection of architecture and social justice, inclusion and exclusion, diversity, transparency, accessibility, borders and conflicts, systemic inequalities, and methodological challenges.

Since late submissions cannot be considered, it is recommended that proposals be submitted before the deadline.

Submission Guidelines

Session proposals must be submitted online by 11:59 pm Central Standard Time, on Thursday, January 9, 2025. Conference Chair Swati Chattopadhyay and members of the Annual Conference Session Selection Committee will review and select the session proposals.

Prospective session chairs must include the following in their proposal:

- A session title not longer than 65 characters, including spaces and punctuation
- Summary of the subject and the premise in no more than 300 words
- Your name, professional affiliation (if applicable), address, telephone, and email address
- A current CV (2 pages max)
